COLONIAL AFFIDAVITS ACT, 1859
22 & 23 Vic. c. 12 (Imperial)**

An Act to enable Colonial Legislatures to repeal certain Provisions of the Imperial Acts of the Fifty-fourth Year of George the Third, Chapter Fifteen, and of the Fifth and Sixth Years of William the Fourth, Chapter Sixty-two.

[8 August 1859]

Short title was given to this Act by the Short Titles Act, 1896, 59 & 60 Vic. c. 14 (Imperial).

Preamble recites 54 Geo. 3, c. 15; 5 & 6 Will. 4, c. 62; ss. 15, 17 (Imperial).
1. (Repealed by the Statute Law Revision Act, 1875, 38 & 39 Vic. c. 66 (Imperial).)

2. Colonial legislatures may repeal, alter, or amend provisions of recited Acts. It shall be lawful for the legislature or other legislative authority of any of Her Majesty's possessions abroad to which any of the provisions contained in the said first-recited Act, or in the fifteenth or seventeenth section of the said secondly-recited Act, shall apply, to repeal, alter, or amend all or any of the provisions, so far as applicable to such possession, in like manner and subject to the same conditions as if the same had been originally enacted by such legislature or legislative authority.

The statute 54 Geo. 3, c. 15, was the New South Wales (Debts) Act, 1813. Sections 1-3 of that Act were repealed as to Queensland by the Supreme Court Act of 1863 (27 Vic. No. 14), s. 33. For s. 4 of the New South Wales (Debts) Act, 1813, see title PRACTICE.

Sections 15 and 17 of the statute 5 & 6 Will. 4, c. 62, relate only to declarations required for the purposes of the repealed sections of the New South Wales (Debts) Act, 1813, and have not been printed in this edition of the Statutes.

COLONIAL LAWS VALIDITY ACT, 1865
28 & 29 Vic. c. 63 (Imperial)**

An Act to remove Doubts as to the Validity of Colonial Laws.

[29 June 1865]

Short title was given to this Act by the Short Titles Act, 1896, 59 & 60 Vic. c. 14 (Imperial).

WHEREAS doubts have been entertained respecting the validity of divers laws enacted or purporting to have been enacted by the legislatures of certain of Her Majesty's colonies, and respecting the powers of such legislatures, and it is expedient that such doubts should be removed:

1. Definitions. The term "colony" shall in this Act include all of Her Majesty's possessions abroad in which there shall exist a legislature, as

herein-after defined, except the Channel Islands, the Isle of Man, and such territories as may for the time being be vested in Her Majesty under or by virtue of any Act of Parliament for the government of India:

The terms "legislature" and "colonial legislature" shall severally signify the authority other than the Imperial Parliament or Her Majesty in Council, competent to make laws for any colony:

The term "representative legislature" shall signify any colonial legislature which shall comprise a legislative body of which one half are elected by inhabitants of the colony:

The term "colonial law" shall include laws made for any colony either by such legislature as aforesaid or by Her Majesty in Council:

An Act of Parliament or any provision thereof, shall, in construing this Act, be said to extend to any colony when it is made applicable to such colony by the express words or necessary intendment of any Act of Parliament:

The term "governor" shall mean the officer lawfully administering the government of any colony:

The term "letters patent" shall mean letters patent under the Great Seal of the United Kingdom of Great Britain and Ireland.

2. Colonial laws, when void for repugnancy. Any colonial law which is or shall be in any respect repugnant to the provisions of any Act of Parliament extending to the colony to which such law may relate, or repugnant to any order or regulation made under authority of such Act of Parliament, or having in the colony the force and effect of such Act, shall be read subject to such Act, order, or regulation, and shall, to the extent of such repugnancy, but not otherwise, be and remain absolutely void and inoperative.

As to the occasion of this Act, see note to s. 2 of the Statute of Westminster, 1931, title COMMONWEALTH AND STATES.

The rights of the Imperial Parliament to legislate for a colony are preserved. Under this section the local legislature may not enact anything repugnant to such Imperial legislation (*R. v. Marais, Ex parte Marais*, [1902] A.C. 51; *Naden v. R.*, [1926] A.C. 482). But this section does not apply to repugnancy to Imperial statutes which are law in a colony by virtue of the settlement and establishment of the colony by British settlers (*Vincent v. Ah Yeng* (1906), 8 W.A.L.R. 145).

This section does not render invalid a provision in a Queensland Act which is inconsistent with the Constitution Act of 1867, *post*, but does not constitute an express amendment of that Act (*McCawley v. R.*, [1920] A.C. 691).

The powers given by the Commonwealth Constitution Act, 1900 (title COMMONWEALTH AND STATES), to the Commonwealth Parliament to legislate upon certain subjects, were held not to exclude the applicability of this section to legislation under such powers (*Union Steamship Co. of New Zealand Ltd. v. Commonwealth* (1925), 36 C.L.R. 130). The section, however, ceased to apply to legislation of the Commonwealth on the adoption by the Commonwealth of s. 2 of the Statute of Westminster, 1931, s. 10, title COMMONWEALTH AND STATES, see Statute of Westminster Adoption Act, 1942 (Commonwealth).

For decisions as to whether this section applies or not, see *A.-G. for Queensland v. A.-G. for the Commonwealth* (1915), 20 C.L.R. 148; 22 C.L.R. 322 (Commonwealth Land Tax Assessment Act not repugnant to Imperial Acts vesting control of Crown lands in State Parliaments); *Union Steamship Co. of New Zealand v. Commonwealth, supra* (provisions in Commonwealth Navigation Act, 1910, repugnant to provisions in Imperial Merchant Shipping Act, 1894); *Australasian Steam Navigation Co. v. Smith* (1885), 7 N.S.W.L.R. (L.) 207 (provisions of State Navigation Act repugnant to those of Imperial Merchant Shipping Act, 1873); *Commonwealth v. Kreglinger Fernau Ltd.* (1926), 37 C.L.R. 393 (Commonwealth Act limiting appeal to High Court from State courts exercising federal jurisdiction, and the Judicial Committee Act, 1844, empowering Crown to provide for appeal from any colonial

court); *Re Robert Barbour* (1891), 12 N.S.W.L.R. (L.) 90 (provision of N.S.W. Crown Lands Act, 1889, repugnant to Imperial legislation giving right of appeal to the Privy Council); *Rusden v. 3. Colonial laws, when not void for repugnancy. No colonial law shall be or be deemed to have been void or inoperative on the ground of repugnancy to the law of England, unless the same shall be repugnant to the provisions of some such Act of Parliament, order, or regulation as aforesaid.

4. Colonial laws not void for inconsistency with instructions to Governors. No colonial law passed with the concurrence of or assented to by the governor of any colony, or to be hereafter so passed or assented to, shall be or be deemed to have been void or inoperative by reason only of any instructions with reference to such law or the subject thereof which may have been given to such governor by or on behalf of Her Majesty, by any instrument other than the letters patent or instrument authorizing such governor to concur in passing or to assent to laws for the peace, order, and good government of such colony, even though such instructions may be referred to in such letters patent or last-mentioned instrument.

5. Colonial legislatures may establish, etc., courts of law. Representative legislatures may alter their constitutions. Every colonial legislature shall have, and be deemed at all times to have had, full power within its jurisdiction to establish courts of judicature, and to abolish and reconstitute the same, and to alter the constitution thereof, and to make provision for the administration of justice therein; and every representative legislature shall, in respect to the colony under its jurisdiction, have, and be deemed at all times to have had, full power to make laws respecting the constitution, powers, and procedure of such legislature; provided that such laws shall have been passed in such manner and form as may from time to time be required by any Act of Parliament, letters patent, Order in Council, or colonial law for the time being in force in the said colony.

In *Taylor v. A.-G. for Queensland* (1917), 23 C.L.R. 457, this section was held to empower the Parliament of Queensland to pass the Parliamentary Bills Referendum Act of 1908 (not reprinted) which provided that where a bill passed by the lower House in two successive sessions had, in the same two sessions, been rejected by the upper House, it should become law on an affirmative vote of the electors followed by the assent of the Crown. In *McCawley v. R.*, [1920] A.C. 691, it was held to confer power on a colonial legislature to appoint a judge of the Supreme Court for a limited period, notwithstanding s. 15 of the Constitution Act of 1867, p. 738 *post*.

6. Certified copies of laws assented to or Bills reserved to be prima facie evidence that they are properly passed. Proclamation as to Her Majesty's disallowance or assent, published in colonial newspaper, to be prima facie evidence of disallowance or assent. The certificate of the clerk or other proper officer of a legislative body in any colony to the effect that the document to which it is attached is a true copy of any colonial law

assented to by the governor of such colony, or of any Bill reserved for the signification of Her Majesty's pleasure by the said governor, shall be prima facie evidence that the document so certified is a true copy of such law or Bill, and, as the case may be, that such law has been duly and properly passed and assented to, or that such Bill has been duly and properly passed and presented to the governor; and any proclamation purporting to be published by authority of the governor in any newspaper in the colony to which such law or Bill shall relate, and signifying Her Majesty's disallowance of any such colonial law, or Her Majesty's assent to any such reserved Bill as aforesaid shall be prima facie evidence of such disallowance or assent.

THE COLONIAL LETTERS PATENT ACT, 1863

An Act to determine the Time at which Letters Patent shall take effect in the Colonies.

[28 July 1863]

Short title was given to this Act by the Short Titles Act, 1896, 59 & 60 Vic. c. 14 (Imperial).

WHEREAS Her Majesty hath from time to time caused to be made under the Great Seal of the United Kingdom of Great Britain and Ireland divers letters patent intended to take effect within Her Majesty's Colonies and possessions beyond the seas: And whereas doubts are entertained respecting the period at which such letters patent have taken or may hereafter take effect within such colonies and possessions:

1. Existing letters patent not to take effect in colonies till published or acted on. Acts done under such letters patent valid. No such letters patent heretofore made shall (unless otherwise provided therein or by other lawful authority) be deemed to have taken or shall take effect in any such colony or possession as aforesaid until the same were or shall be publicly made known or acted upon therein: Provided, that any act or thing heretofore done or purporting to have been done in pursuance or under authority of such letters patent shall be as valid and effectual as if the same letters patent had taken effect at the date of the making thereof.

This section applies to Letters Patent of 6 June 1859, constituting the Colony of Queensland, p. 800 *post*.

2. Future letters patent not to take effect in colony till publication. No such letters patent hereafter to be made shall (unless otherwise provided therein or by other lawful authority) take effect in any such colony or possession until the making of the same shall have been signified therein by proclamation or other public notice.
